## WHO

All Licensed CPAs in the State of Michigan



## WHAT

The State of Michigan now requires all licensed Michigan CPAs earn one hour of state-specific ethics each reporting period to maintain their license. Thus, of the four hours of ethics required every two years – one of these hours must now be Michigan Specific Ethics 2019-21 Edition.

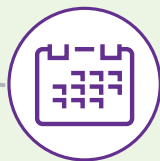

## WHEN

Governor Rick Snyder signed into law legislation for a new state-specific ethics requirement in March of 2018. The new requirement for licensure began on June 17, 2018.

**All licensed Michigan CPAs must earn 1 hour of Michigan Specific Ethics 2019-21 Edition by June 30, 2021.**

NOTE: You may only earn one credit of Michigan Specific Ethics per earning year, with one counting towards the renewal of your license in 2021 and the possibility to carryover one hour to the 2023 licensing cycle.



## WHY

The Department of Licensing and Regulatory Affairs (LARA) and the Michigan State Board of Accountancy recognized a growing concern that Michigan's CPA licensees need to know the Accountancy Act and Administrative Rules in Michigan.

In working with LARA, the MICPA took on the responsibility to serve as the content creator for a new course, Michigan Specific Ethics, to increase the licensees' awareness of their statutory requirements to avoid penalty.

Not knowing licensure requirements can end up costing licensees money, credibility and ultimately, the ability to practice.
